The consulting services for Production of Black Soldier Fly (BSF) as an alternative source of protein for the local chicken for increased productivity in Kiambu County on time-based basis over an estimated period of twelve months.NARIGP development objective is "to increase agricultural productivity and profitability of targeted rural communities in selected Counties." The Services will comprise the following major activities with a view of increasing productivity at farm level and profitability at all levels of the value chain;

- a) Sensitization of the local chicken Producer Organization (PO) members on the BSF technology as an alternative source of protein
- b) Capacity building of the POs who constitute the CIGs and VMGs along the chicken VC. Building their capacities to produce BSF profitably and sustainably
- c) Set up 3 BSF demonstration production centres as per the BQ provided in the 3 implementing wards i.e. Karai, Ndeiya and Nachu in consultation with the POs
- d) Operationalize demonstration centres to serve as the source of seed (instar 5) for the BSF farmers qualifying per the agreed criteria with the POs to adopt the technologies
- e) Follow up, support and ensure the farmers have adopted the BSF technology
- f) Operationalize the demonstration centres to also serve as a source of protein feed (instar 5) to the local chicken farmers as per the agreed criteria with the POs
- g) Capacity building of the POs on value addition and management of the organic manure from the BSF rearing to improve soil fertility critical to improving agricultural production for food and nutrition security
- h) Implement strategies for social inclusion, and gender mainstreaming while fostering an enabling environment in the adoption of the technology.

The County Government of Kiambu now invites eligible consulting firms on local chicken to indicate their interest in providing the Services. Interested Consultants should provide information

demonstrating that they have the required qualifications and relevant experience to perform the Services. The shortlisting criteria are:

- (i) Minimum of five years' relevant experiences (2015 to present) and technical capacity in provision of technical, business, financial and organizational advisory services (provide details);
- (ii) At least three (3) assignments of similar nature in the past five years (2015 to present), one of which should have been in similar value chain; and
- (iii) Demonstrable experience in providing advisory services on primary production TIMPs (provide details).

Key Experts will not be evaluated at this stage.
