#### 01/08/2019 PRELIMINARIES

The chairman gave his opening remark by welcoming the Board Members and reminding them of the importance of the quarterly meeting.

## 02/08/2019 PROGRESS OF THE LIMURU BUS PARK

- The manager reported on the progress of the improvement of Limuru Bus Park, Storm Water And Street Lightening in Limuru Town. It was reported that the completion per cent age is 27% which was ahead of time.
- The issue of transfer station still remains thorny. The Board had visited Gitogothi site and agreed with the community to allow establishment of the transfer station and they had formed a committee to oversee that,
- The manager reported that CEC Maina had requested to meet the committee together with the Governor,

- It was reported the Municipality had received a tipper for waste management,
- · Back hole and skips are yet to be delivered,
- The board agreed that the business people who need to connect the sewer system need to do that before the tarmarcing of Bus Park.

#### 03/08/2019 KAMBAA ROAD

- It was reported that Kambaa road project was behind time and completion percentage,
- The manager reported that he had written to the RE concerning slow progress in the work,
- A meeting had been held between the contractor and the Waziri to hasten the pace of the contractor.

### 04/08/2019 FY 2019/2020

- The manager reported that the screening of the project were on going,
- The Mukuru road corridor has less width in some sections,
- The surveyor was reported to be on site taking measurements and the Board will act accordingly after the surveyors' report,
- The Board will await the technical report to address this,
- The Board observed that, the issue of splitting the money meant for Soko Mjinga between Soko and Ngecha market was not in line with the World Bank guidelines,
- The board proposed that instead of dividing the fund allocated for the market construction the whole 60 million go to Soko Mjinga
- The market should also have hospitality section with proper parking space,
- Acceleration and deaccerelation lanes,
- Street lighting,
- Public participation need to be done,
- Working in partnership with the design of the Nakuru Nairobi highway,
- The board would want to seat with the designer of the market before the drawings are done.
