#### **DESCRIPTION OF REQUIREMENTS**

The County Government of Kiambu seeks to acquire an innovative fleet management system for assisting the County Executive monitor and optimize the use of the County Vehicles, Plant and Machinery for maximum service delivery.

The scope of work will be at minimum as follows:

- Provide fleet tracking and management
- Driver management.
- Vehicle management.
- Geo fencing
- Reporting.

In providing the fleet management system to the county, the following shall apply

- 1. The interested Partner Company/ Companies, Consortium must demonstrate capacity to offer the services with modern technology including GPS, GSM, Dashboards.
- 2. The interested partner should have been in operation for at least 5 years and can demonstrate success in the fleet management space.
- 3. Able to provide all necessary hardware to support the da-to-day running of the system including remote vehicle monitoring, immobilization, and safety measures.
- 4. Demonstrate ability to innovatively monitor, analyze fuel consumption, mileage and repair/routine service and maintenance including alerts and prompts for service checks.
